The Eleventh Africa Energy Indaba



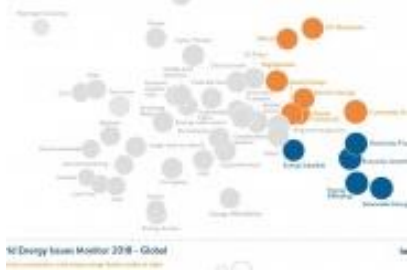
